ALLIED HEALTH PROFESSIONALS ASSOCIATE - FULL MEETING

IN ORDER TO QUALIFY FOR A TRAVEL GRANT – YOU MUST BE AN ACTIVE CSACI ALLIED HEALTH MEMBER (FOR AT LEAST TWO FULL YEARS) IN GOOD STANDINGS (ALL PRIOR AND CURRENT DUES MUST BE PAID).

Travel grants for the Allied Health associates will be made available for travel and expenses incurred while attending:

- CSACI Annual Scientific Meeting for up to \$750 per applicant and up to an additional \$250* for those presenting an abstract

The CSACI will only accept:

- Electronic and scanned receipts will be accepted; and
- Detailed hotel receipts to support the claim of expenses is required

MANDATORY INFORMATION:

- **YOU MUST INCLUDE THE AMOUNT AND INSTITUTION FROM ANY OTHER FUNDING SOURCE.**
- The CSACI travel grant (outside of the metropolitan area) will cover a portion of the costs of meeting registration, travel (airfare) and airport transfers as well as standard accommodation (single) at the designated host hotel. **(NO ALLOWANCES FOR FOOD).**

The above guidelines are dependent on the financial position of the society. Travel grants may be cancelled at any time if finances do not allow disbursement of these travel grants.
